

M H A part of Lot 14, Block 2, Section 16 as shown on map of Ridgewood as recorded in Deed Book "Q", Page 663 of the Public Records of Clay County, Florida, also being known as a portion of Lot 14, Section 16 as shown on map of Ridgewood as recorded in Plat Book 1, page 23 of said Public Records of Clay County, Florida and being more particularly described as follows:

Commence at the most westerly corner of Tract "C" as shown on map of the Meadows Unit Two, as recorded in Plat Book 16, Pages 56, 57 and 58 of said Public Records of Clay County, Florida; Thence North 56°11'A1" East and on the Northwesterly boundary of said tract "C", 110.0 Feet to the Point of Beginning. From the point of beginning thus described, thence North 45°08'55" West, 305.98 feet to a point on the southeasterly right-of-way line of Blanding Boulevard, State Road No. 21; thence North 56°11'41" East, and on said southeasterly right-of-way line, 226.7 feet to the northeast corner of said Lot 14; thence south 45°08'55" East and on the Northeasterly boundary line of the aforementioned Lot 14, a distance of 305.98 feet; thence South 56°11'41" East along the northwesterly boundary of said Tract "C", a distance of 226.7 feet to the point of beginning.

Subject to a 10.0 foot wide easement to Kingsley Service Company, lying parallel and adjacent to Blanding Boulevard and being subject to a 25 foot wide easement for drainage and utilities lying parallel and adjacent to the northwesterly boundary of said Tract "C" of The Meadows Unit Two.
